Subject: **Adopt resolution reciting the facts of the consolidated municipal election held on June 7, 2016, declaring the results, and such other matters as provided by law**

**Recommended Motion/Item Description**

That the City Council adopt the resolution as presented.

**Background**

State law requires that the Council adopt a resolution reciting the facts of the election for the three Council seats and the fire tax.

**Findings**

The official vote count in the Certificate of Canvass of Vote by the Marin County Registrar of Voters is:

Bob McCaskill	642
Claire McAuliffe	640
Nancy Kemnitzer	597
Measure B – Yes	680
Measure B – No	200

The number of residents registered to vote in Belvedere was 1,440; 717 ballots were cast by mail and 242 ballots were cast at the poll for a total of 959 ballots and a 66.60% voter turnout (up from 39% in the 2014 council election).

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELVEDERE,  
RECITING THE FACTS OF THE CONSOLIDATED MUNICIPAL ELECTION HELD  
ON JUNE 7, 2016, DECLARING THE RESULT, AND SUCH OTHER MATTERS AS  
PROVIDED BY LAW**

---

**WHEREAS**, a Consolidated Municipal Election was held and conducted in the City of Belvedere, California, on Tuesday, June 7, 2016, as required by law; and

**WHEREAS**, that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of consolidated elections in general law cities; and

**WHEREAS**, pursuant to Resolution No. 2016-01, adopted January 11, 2016, the County Registrar of Voters canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit "A."

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Belvedere as follows:

**SECTION 1.** That the whole number of ballots cast in the City was 959.

**SECTION 2.** That the names of persons voted for at the election for Member of the City Council were Nancy Kemnitzer, Bob McCaskill, and Claire McAuliffe.

**SECTION 3.** That the following measure was voted upon: Measure C, City of Belvedere, Fire and Emergency Medical Services Appropriations Limit Adjustment.

**SECTION 4.** That the number of votes given in the City to each of the persons above named are as listed in Exhibit "A" attached.

**SECTION 5.** The City Council does declare and determine that: Bob McCaskill, Claire McAuliffe, and Nancy Kemnitzer were elected as Member of the City Council for the full term of four years.

**SECTION 6.** The City Council does declare and determine that Measure C passed and is adopted.

**SECTION 7.** The City Clerk shall enter on the records of the City Council of the City a statement of the result of the election, showing: (a) The whole number of votes cast in the City; (b) The names of the persons voted for; (c) The measures voted upon; (d) For what office each

person was voted for; (e) The number of votes given in the City's single precinct to each person and for and against each measure.

**SECTION 8.** That the City Elections Official shall immediately sign and deliver to each of the persons so elected a Certificate of Election signed by the City Elections Official and authenticated. That the City Elections Official shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California.

**SECTION 9.** That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.

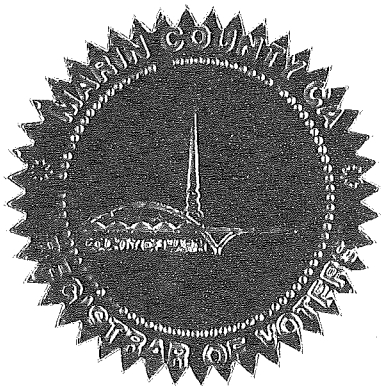
